We will also introduce recent ICAEW-Deloitte research on audit committees. Based on in-depth interviews with audit committee members in seven CEE countries, a shared ICAEW – Deloitte report, **Making a difference: audit committees in Central and Eastern Europe**, published during the summer of 2017, draws out insights on how audit committees are working, how they are having an impact and how they view the future. It provides insights into some of the common challenges still remaining at a time when the role of audit committees is expanding, largely driven by the introduction of new statutory requirements.

A reception with networking opportunities will follow.
